

This notice is given pursuant to the Open Meeting Act, Chapter 551, Government Code.

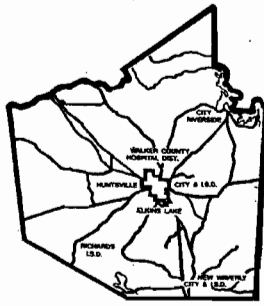

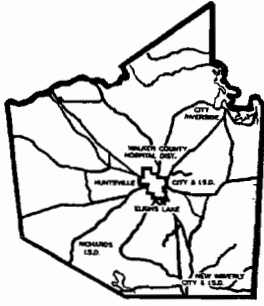
